### **TERMS & CONDITIONS OF USE FOR SEASON TICKETS**

1. Upon every use ALL Season Ticket Holders must personally present their Season Ticket for swiping in the Pro-Shop prior to commencement of their round.
2. The Season Ticket is not transferable.
3. The Season Ticket entitles the holder to play unlimited rounds of golf on the Course during the periods covered by the category of ticket on payment of the appropriate Supplementary Fee in respect of each round played.
4. The Supplementary Fee - Adult £1.50 (weekend), 75p (weekend pm) and 50p (weekday), Concessions/Card/Young Adult £1.50 (weekend), 75p (weekend pm) and 25p (weekday), Juniors 25p (weekend, weekend pm and weekday) - which must be paid prior to commencement of play during the Golf Professional's Shop opening hours. At other times the fee must be paid at the earliest opportunity or to the Golf Course Attendant on request.
5. Season Tickets and Supplementary Fee receipts must be produced for inspection by the Course Attendant on request.
6. Link4Life reserves the right to withdraw these entitlements in the event of abuse of these conditions without refund of any fees paid.
7. 'Golf Course Attendant' means any person employed or duly authorised by Link4Life to act in this capacity.
8. Season Ticket holders must comply with other conditions of use as from time to time displayed at the Golf Professional's Shop or on the Course itself.
9. Season Ticket Charges are only refundable in exceptional circumstances and entirely at the discretion of the appropriate Head Of Service.
10. There is a charge for a Replacement pass of £3.00.
